It has come to know that M/S Daniyal Publications, 328-F, Bukhari Market, Link Wahdat Road, Lahore has published the book titled "Urdu O-Level, Syllabus-B" without prior approval of the Punjab Curriculum and Textbook Board (PCTB), which is violation of Section 10 (1) of the Punjab Curriculum and Textbook Board Act, 2015 under which no person shall, except with the prior approval of the Board, print, publish, sell or prescribe in an institution any textbook or supplementary material.

- 2. The subject mentioned book must not be used as textbook, supplementary reading material, reference book or guide book, etc. at any level till the issuance of No Objection Certificate by the PCTB to the objection-free draft of the book.
- 3. It is to be treated as most important / urgent and strict compliance be ensured.
