M/S Javed Publisher, 17-Urdu Bazar, Lahore has developed the books titled "General Knowledge Grade-I", "General Knowledge Grade-II" and "General Knowledge Grade-III". These books have not been cleared by the Punjab Curriculum and Textbook Board (PCTB) and No Objection Certificates (NOCs) to these books have not been issued by PCTB.

- 2. The above mentioned books are hereby banned by the Punjab Curriculum and Textbook Board (PCTB) for printing / publishing, selling and adoption in any educational institution of the Punjab province.
- 3. As per Section 10 (1) of the Punjab Curriculum and Textbook Board Act, 2015; No person shall, except with the prior approval of the Board, print, publish, sell or prescribe in an institution any textbook or supplementary material.
